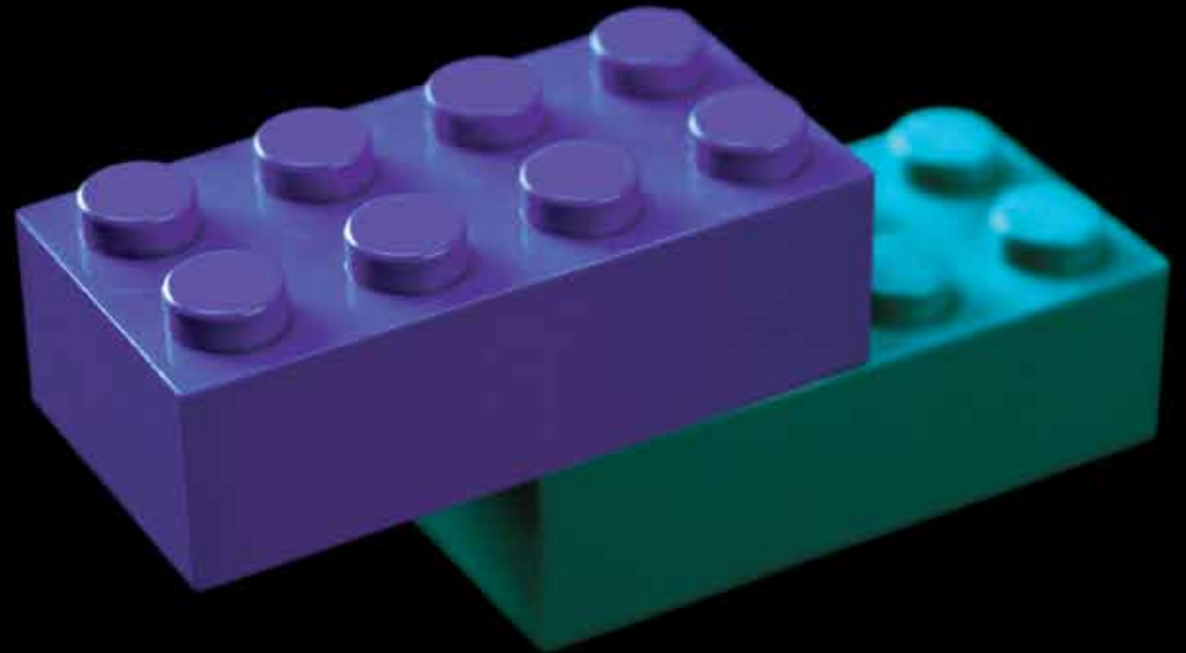

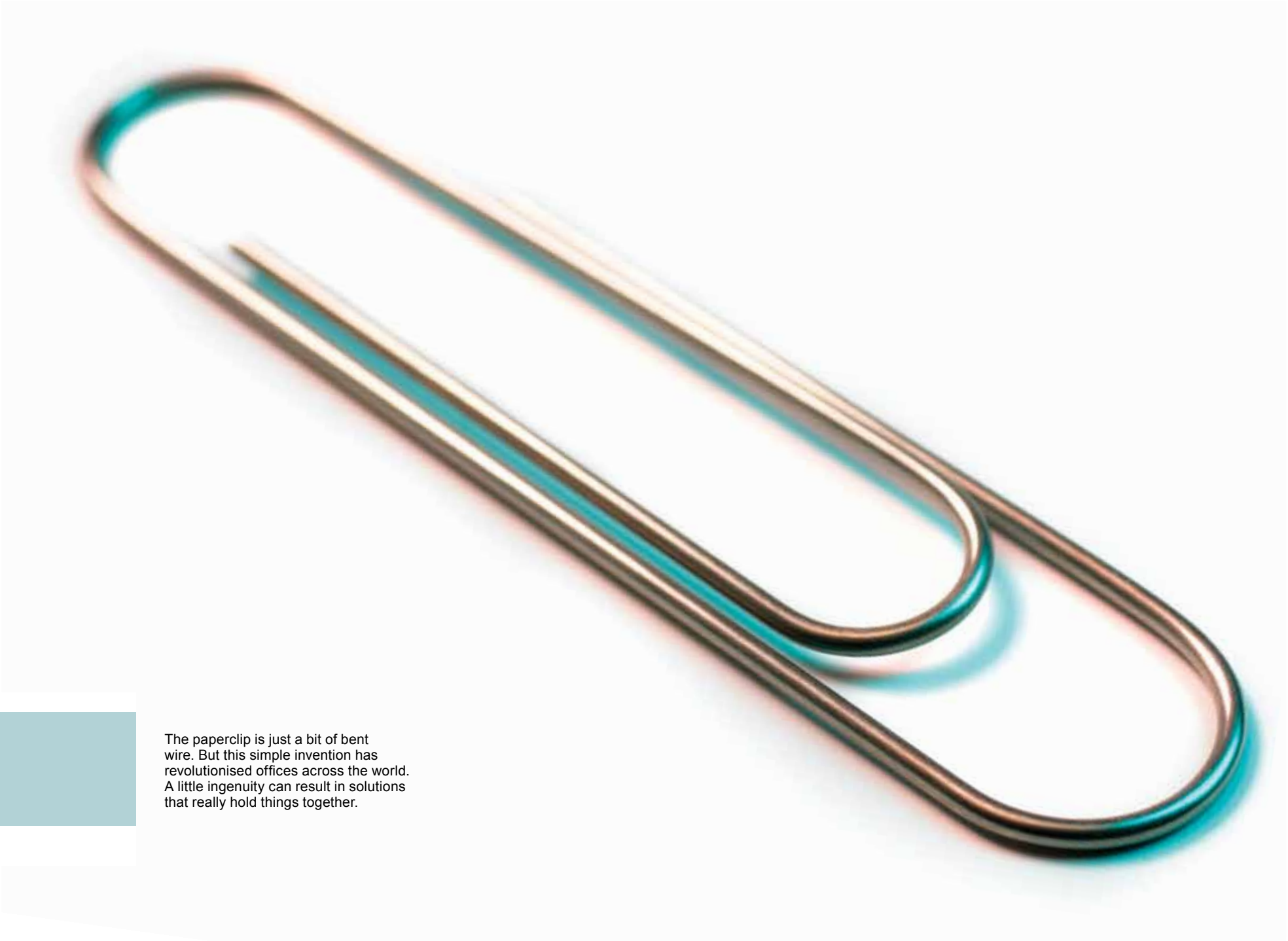

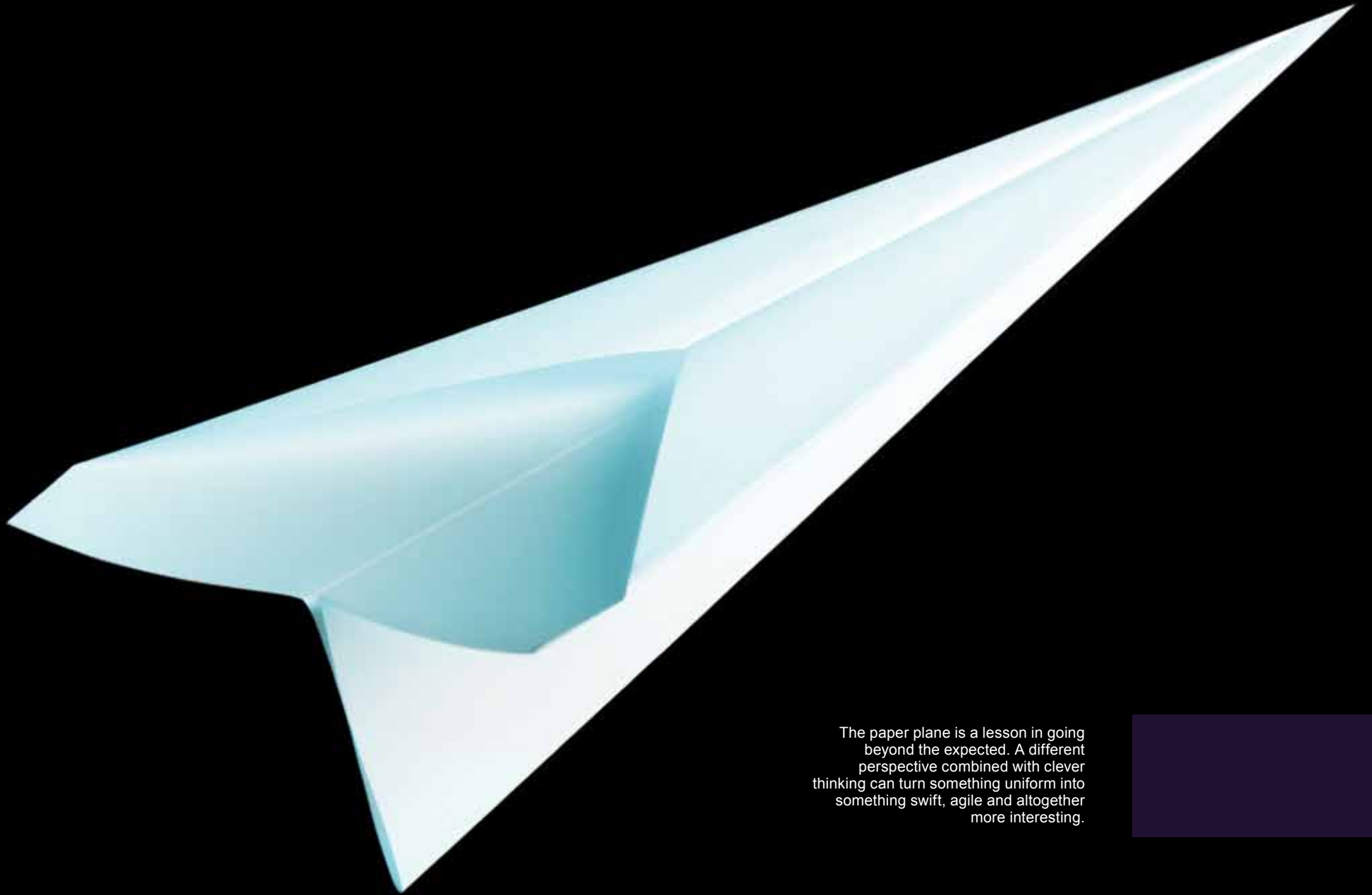

Real estate

We advise on the full range of property-based transactions, including developments and investments, acquisitions and disposals, joint venture agreements, partnering, the granting and taking of leases, rent reviews and property portfolio management. We are also leaders in contentious property and planning work. Public regulatory
